The Oracle Audit Process

An Oracle audit starts with a formal notification of the company's intention to perform an audit, usually sent via email or post.

Upon receipt of the audit notification a customer, contractually, has **30 days** to engage with Oracle and start the audit process.



A typical audit will cost Oracle between \$20,000 and \$40,000 to conduct, and it expects a significant return on its investment.
